Punctuality

5. Timely arrival at school plays a crucial role in ensuring that your child/ward starts the day smoothly, minimising disruptions to their learning experience. As such, it is important for you to partner us in ensuring that your child/ward maintains regular attendance and arrives punctually to school each day.

6. Prompt arrival allows students to settle into the learning environment, participate in morning routines, and benefit fully from instructional time. All students are expected to be in the Hall / classroom by 7.30 am for morning assembly. We kindly request your support in ensuring that your child/ward arrives at school on time.

7. We will be sending advisory letters to parents/guardians of students who have been late for school after repeated reminders. We hope to engage and work with you to help your child/ward observe punctuality as it sets a positive example for our young learners, reinforcing the value of responsibility and respect for schedules, and creating a conducive environment for effective learning and growth.

Students with Medical Conditions

8. If your child/ward has medical conditions, such as asthma, please ensure that he/she brings along his/her personal medication to school. The medication must be clearly labelled with the child's/ward's name and class. Do check that the medication is not expired, and your child / ward is capable of self-administering it.

9. Please update the school immediately if your child / ward has a medical condition. This will allow teachers to monitor the students' well-being.

Updating of Parents' / Guardians' Contact Details

10. You are urged to update your contact details such as home address and contact numbers when there are changes. This allows the school to inform parents / guardians immediately during an emergency. You may make the changes via https://pg.moe.edu.sg/forms/sdf.

11. Contact details of your child/ward should also be updated in his/her student organiser.

Cashless Payments for Fees and Enrichment Programmes

12. We would like to invite you to sign up for GIRO payments for your child'/ward's monthly fees and enrichment programmes, if you have not done so.

13. You need only to complete a simple FormSG available at MOE's website <u>https://www.moe.gov.sg/financial-matters/fees</u>. If you have accounts with banks that are not listed on the website, you may request for a GIRO form from us. Please call us at 65624370 for assistance

14. Opting for cashless payments ensures that your child / ward need not carry cash to school to make payment. As the payments are scheduled, you also need not worry about missed payments.





Important Reminder: Protecting Our Youth from Vaping

15. E-vaporisers are illegal in Singapore. Under the Tobacco (Control of Advertisements and Sale) Act, the possession, use or purchase of e-vaporisers carries a maximum fine of \$2,000. It is also an offence to import, distribute, sell or offer for sale e-vaporisers and their components. Any person convicted of such offences is liable to a fine of up to \$10,000, or imprisonment of up to six months or both for the first offence, and a fine of up to \$20,000, or imprisonment of up to 12 months or both for the second or subsequent offence. All prohibited tobacco items will be seized and confiscated.

16. MOE takes a firm stand against vaping. Vaping is categorised as a serious offence. When students are caught using or in possession of e-vaporisers, the prohibited product will be confiscated, and parents will be informed. The schools will report the offender to HSA and manage vaping-related offences through existing disciplinary frameworks. These include taking school-based disciplinary actions, such as suspension or caning (for boys). Students caught vaping will also be placed on cessation support programmes where counsellors will guide them through their cessation journey to effect long-term behavioural change.

17. You have an important part to play in your child's/ward's education. There are resources and relevant information for you in Parent Hub. You are encouraged to have a conversation with your child/ward about the harmful effects of vaping to prevent it from becoming a life-long habit.
